4. FIRST AID MEASURES			
Inhalation:	Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. Get medical attention.

5. FIF	RE FIGHTING MEASURES

Unusual fire or explosion hazards:

6. ACCIDENTAL RELEASE MEASURES

Use personal protection recommended in Section 8, is olate the hazard area and deny entry to unnecessary and unprotected personnel.

Environmental precautions:	Do not allow product to enter sew er or waterways. Prevent further leakage or spillage if safe to do so. Advise authorities if product has entered or may enter sew ers, water sources or extensive land areas. This product is insoluble in w ater and w ill float on surface.
Clean-up methods:	Remove all sources of ignition. Ventilate area. Wear suitable protective clothing, gloves and eye/face protection. Keep upw ind of the spilled material and isolate exposure. Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, saw dust). Store in a partly filled, closed container until disposal.

7. HANDLING AND STORAGE

Handling:
