Section 2. Hazards identification

Prevention

Description of necessary first aid measures

Eye contact

Section 4. First aid measures

Skin contact

: Wash skin thoroughly with soap and water or use recognized skin cleanser. Remove contaminated clothing and shoes. Section 6. Accidental release measures

Large spill

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product. Section 8. Exposure controls/personal protection

Environmental exposure controls


