This product contains methylpolysiloxanes which can generate formaldehyde at approximately 300 degrees F (150 C) and above, in atmospheres which contain oxygen. Formaldehyde is a skin and respiratory sensitizer, eye and throat irritant, acute toxicant, and known cancer hazard. Workplace exposure to formaldehyde is regulated by OSHA Standard 29 CFR 1910.1048.
