Prevention:

4. FIRST AID MEASURES

Inhalation: Move to fresh air. If not breathing, give artificial respiration. If breathing is

difficult, give oxygen. Get immediate medical attention.

Skin contact: Remove contaminated clothing and footwear. Immediately flush skin with

plenty of water (using soap, if available). If symptoms develop and persist, get

medical attention. Wash clothing before reuse.

Eye contact: Rinse immediately with plenty of water, also under the eyelids, for at least 15

minutes. Get medical attention.

Ingestion: Keep individual calm. Do not induce vomiting: contains petroleum distillates

and/or aromatic solvents. If vomiting occurs, prevent aspiration by keeping the

5. FIRE FIGHTING MEASURES

Extinguishing media: Water spray (fog), foam, dry chemical or carbon dioxide. Do not use high

volume water jet.

Special firefighting procedures: Wear self-contained breathing apparatus and full protective clothing, such as

turn-out gear. Water may be unsuitable as an extinguishing media, but may be

helpful in keeping adjacent containers cool.

Unusual fire or explosion hazards: Contents under pressure. Do not puncture or incinerate pressurized

containers. Containers exposed to fire should be cooled with water to prevent vapor pressure buildup which could result in container rupture. If a leak or spill has not ignited, use water spray to disperse vapors. The liquid is volatile and gives off invisible vapors. Vapors may form explosive mixtures with air. Do not handle or store near an open flame, heat or other sources of ignition. Hydrocarbon solvents are basically non-conductors of electricity and can become electrostatically charged during mixing, filtering or pumping at high flow rates. If this charge reaches a significantly high level, sparks can form

that may ignite vapors of flammable liquids.

Hazardous combustion products: Oxides of carbon. Hydrocarbons. Toxic and irritating vapors.

6. ACCIDENTAL RELEASE MEASURES

Use personal protection recommended in Section 8, isolate the hazard area and deny entry to unnecessary and unprotected personnel.

Environmental precautions: Do not allow product to enter sewer or waterways. Advise authorities if product

has entered or may enter sewers, water sources or extensive land areas. This

product is insoluble in water and will float on surface.

Clean-up methods: Remove all sources of ignition. Evacuate and ventilate spill area; dike spill to prevent entry into water system; wear full protective equipment during clean-

up. Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Store in a partly filled, closed container until disposal. Vapors are heavier than air and may travel along the ground or be moved by ventilation and subsequently ignited by heat, pilot lights or other ignition sources at locations distant from the material handling point. Refer to Section 8 "Exposure Controls / Personal Protection" prior to clean up.

7. HANDLING AND STORAGE

Handling: During use and until all vapors are gone: Keep area ventilated - do not

smoke; extinguish all flames, pilot lights, and heaters; turn off stoves, electrical tools and appliances, and any other sources of ignition. Prevent contact with eyes, skin and clothing.
