4. FIRST AID MEASURES

SPECIFIC HAZARDS POSSIBLY ARISING FROM THE CHEMICAL: Flammable liquid and vapor. Vapours are heavier than air and may spread near ground and travel a considerable distance to a source of ignition and flash back. Keep container tightly closed.
