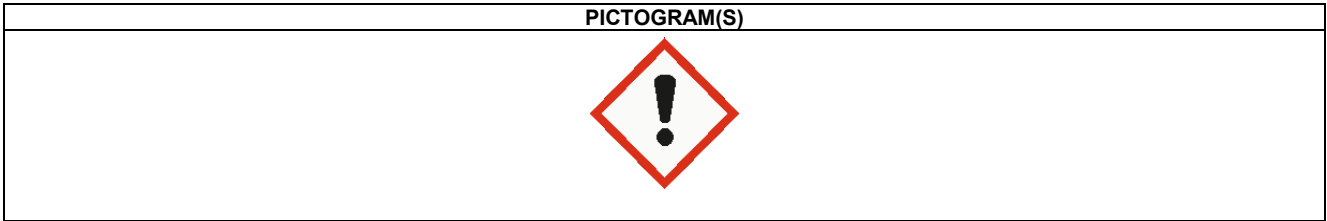

**Clean-up methods:**
